Dear Mr. Hoeffner

This letter is intended to memorialize the agreement between your company and The Sister Sherry Lynn Foundation. The licensee of noncommercial broadcast station KFXT FM. Concerning an application that KFXT will file with the Federal Communications Commission in Washington, D.C.("FCC") to modify the license for KFXT. The application will propose to modify the license of KFXT to change the ERP of KFXT from the existing 3KW to 7KW. The antenna height will remain at 91 Meters HAAT, the operating frequency will remain at 90.7 MHZ, and the location of the transmitter site will remain at N34:32:57 W096:58:34.

Under the terms of our agreement, upon the execution of this letter The Sister Sherry Lynn Foundation will file an application with the FCC to gain the necessary regulatory authority to modify the facilities of KFXT as noted above. Once the FCC has granted a construction permit for the KFXT facility change. KFXT will increase the ERP of KFXT in conformity with the terms and conditions of that authorization. The preceding week after KFXT commences operation with the new ERP, The Sister Sherry Lynn Foundation will publish in the local newspaper a notice at least one-quarter page in size. The notice will instruct anyone who has begun to receive interference to his or her reception of KAUZ-TV to contact Mr. Leon Hauffner Chief Engineer at KAUZ-TV. KFXT will also refer any complaints it receives of interference to the reception KAUZ-TV to Mr. Hauffner.

It is the intent of the parties that KFXT will be responsible for correcting all interference complaints to the reception of KAUZ-TV that are the result of the operation of KFXT with the new ERP. To this end Mr. Hauffner will notify KFXT of the names, addresses

and telephone numbers of all those persons who contact him with interference complaints following the completion of publication of the newspaper notice. It will be the obligation of KFXT to contact each of these persons, to ascertain the source of the interference to their reception of the KAUZ-TV signal, and to correct that interference in the event it is caused by the operation of KFXT-FM. KFXT will provide Mr. Hauffner with a report on its investigation into each of these interference complaints, and the action taken to resolve the problem, within ten (10) days after receiving the information on the complaint. Your company agrees to fully cooperate with KFXT 's efforts in investigating and resolving these interference complaints.

Please countersign this letter at the place provided below to signify your agreement with the terms hereof.

Upon the execution of this letter. KFXT will move forward with the FCC application and will provide you with a copy once it is on file.
